This warranty extends for a period of five (5) years from date of original purchase and only to the original end-user purchaser of the product and is not assignable or transferable to any subsequent purchaser or end-user. If any such defect (in either material or workmanship) appears within five (5) years from the date of purchase, FUJIFILM's entire liability is, at FUJIFILM's option, either (a) repair the product, or (b) replacement of the product, or (c) refund the purchase price of the product, which must be returned to FUJIFILM with proof of purchase, such as a purchase order, invoice or sales receipt.
